1	<p>English Version of UB Text not as per Foundation's Web site license policy</p> <p>The text is not kept "inviolate." (E.g., Uversa Press text; popup footnotes in text; commentary added to the index; first two papers not included in the index to Part IV. Copyright notice states "excerpts ... on this website have been transformed by the addition of an internal reference system designed to facilitate study, scholarship, and cross-referencing")</p> <p>There are many instances where the copyright notice is not displayed prior to the appearance of the reproduced text. (E.g., www.urantiabook.org/index_overview.htm, www.urantiabook.org/index_jesus.htm)</p> <p>"Personal Browser Edition" download version is not current text. Claims copyright in the format for the Fellowship.</p> <p>Ascii download version does not contain any copyright notice. No Italics in text.</p>
2	<p>Spanish Version of UB Text not as per Foundation's Web site license policy (e.g., index includes unauthorized translation listed together with UF's text. There are 3 versions of forward.)</p>
3	<p>Unlicensed display of unauthorized translations in Korean, German, French, Spanish, Portuguese, Croatia, and Russian.</p>
4	<p>(Currently Removed.) Unlicensed display of Sadler works including: "Analytic Study of Part One of <i>The Urantia Book</i>"; "History of the Bible"; "The Theology of <i>The Urantia Book</i> (Parts I-IV)"; "The Teachings of Jesus"; "Short Course in Doctrine – Summary of the Theology of <i>The Urantia Book</i>"</p>
5	<p>Fellowship Herald magazine uses UB text but does not acknowledge copyright.</p>
6	<p>Urantia Book Illustrated on web site quotes over 20,000 words of UB without attribution or permission.</p>
7	<p>McMullan's 21 Steps to a Spiritual Awakening quotes over 25,000 words of UB without permission. Fellowship web site publishes this in English, Spanish and Portuguese</p>
8	<p>Fellowship is soliciting people to assist it in translating the complete Urantia Book into multiple languages in violation of international law.</p>
9	<p>Hyperlink to Michael Foundation, purveyor of the infringing work <i>Jesus: A New Revelation</i></p>
10	<p>Sample of anti-Foundation material</p>
11	<p>Urantianet being used in some places without the agreed disclaimer (per agreement reached in 1997)</p>
12	<p>Infringement of trademarks "Urantia," "Urantian" (E.g., www.urantiabook.org/index_studygroup_database.htm)</p>

13	www.urantiabook.org/bookshop/urantiabooks.html entitled "Best Prices on the Web for Urantia Books" says "Buy the Urantia Book!" and contains price list. Very confusing; it appears they are the source for Urantia Book
14	Registered Internet domain names violate Urantia Foundation trademarks: www.urantiabook.org , www.librourantia.org , www.librourantia.cl , www.urantialink.org , www.urantianet.org , www.urantiaweb.org
15	Fellowship has registered with Real Names as the owner of the name "Urantia," "Urantia Book" and "Libro de Urantia." This means several of the search engines list this link first as "Urantia RN" (similar in appearance to TM), causing confusion with Foundation's trademarks.
16	Fellowship is meta-tagging the words "Urantia," "Foundation," "International Association" "Urantia Book," "Libro de Urantia"
17	Trademark violations of concentric circles symbol
18	Violation of court's confidentiality order re: <u>Maaherra</u> documents. (E.g., Jacque Weiss page).
19	Violation of Sadler copyright in Mind at Mischief in English and Spanish
20	Violation of Urantia Foundation's confidential business records (translator's agreement)
21	Name change - Urantia Book Fellowship
